

“Brother Creative Center”网站使用条款

“Brother Creative Center”网站及其相关服务和内容（定义见下文，下同）（统称“Creative Center”）由位于日本国爱知县名古屋市瑞穗区苗代町15-1号（邮编：467-8561）的日本兄弟工业株式会社（以下简称“兄弟公司”）开发和提供。

本使用条款规定了您使用Creative Center的条款和条件，并适用于因使用Creative Center而产生的所有法律关系。在您遵守本使用条款的前提下，Brother授予您使用Creative Center的权限。在使用Creative Center之前，请仔细阅读本使用条款。如果您不同意这些使用条款，请勿使用Creative Center。Brother可能会根据需要修改这些使用条款，并会在任何此类修改前通知您。如果您同意修改或更新的使用条款，或者如果您在此类修改生效后继续使用Creative Center，则视为您接受修改或更新后的使用条款的约束。
